FIRST LUNCHEON OF 2024 HUGE SUCCESS: Penticton Director Bob Ogden welcomed 41 members and guests to our first luncheon meeting of 2024 held at the new and improved Asian Gardens on Skaha Lake Road on Saturday, Feb. 17th. Greeter Mel Murton made sure all guests were made comfortable in the new seating arrangement. After a busy social hour and catching up with old friends, it was time to try the new Western and Asian cuisine and guests were not disappointed. Following lunch Director Bob introduced Erica Markus-Pawliuk, Assistant Executive Director of the South Okanagan Women in Need Society (SOWINS) who provided a very informative and somewhat disturbing presentation on the important work this charity provides women and families who are victims of spousal abuse. Erica is very qualified to speak on this subject as she has a BA in Child and Youth Care and a Master's Degree in Counselling Psychology. She has accreditation as a Registered Clinical Counsellor with the BC Association of Clinical Counsellors. Erica also serves as the Director of Community Based Programs and Services.

With an annual budget of \$400,00.00 and over 50 staff and volunteers, SOWINS provides 3 transition facilities for those seeking shelter and support from abusive relationships with various programs for both adults and children. The emergency shelter provides 36 beds for women and children and has also allowed the families to bring their pets which lessens the stress. While there is no specific youth shelter SOWINS does provide 3 spaces for affected youths. SOWINS can provide support, counselling and shelter for up to 6 months. Children are taken to parks and recreation facilities by volunteers.

The increase in addiction has led to increased incidents of spousal abuse and the need in the community to offer a safe environment which SOWINS provides. Programs include Sexual Assault Programs including visits to hospitals; Education Series for Safety in Attending Bars; Healthy Food Preparation and even has established long term housing for victims. One alarming trend is that abused women are now being diagnosed with brain injury due to repeated chokings at the hands of their abuser. Some noteworthy statistics are: 1 in 3 women will experience abuse in their lifetime; SOWINS provided over 1400 counselling sessions last year for women and children; provided over 2100 overnight stays for children; and answered over 2000 crisis calls and, serves Penticton, Summerland, Okanagan Falls, Oliver and nearby communities. All services are gratis!

GRAVE HEADSTONES: A recent inquiry was made from a Division member and our Benefit Support Advocate Bruce Cieslikowski was quick to provide the following information:

- The Force will pay for manufacture, transportation and erection of a regimental head stone to a grave in Canada.
- There are 3 styles: 1) upright granite 30" high, 18" wide, 3" thick; 2) granite, flat to ground 12" long, 20" wide, 3" thick, 3) flat to ground bronze 12"x 20" x 1/4" thick.
- The marker must contain RCMP crest, Reg. No. and name of member, Date of Birth and Death.

- Another option is to pay \$220 toward a self- purchased headstone with the condition that some reference of member's service must be on it. A receipt of purchase and photo have to be produced for reimbursement.

CARE AT HOME (FROM THE ADVOCATE DESK)

The Care at Home Resource Guide is available to help Veterans and their families or friends understand the Veterans Affairs Canada (VAC) programs that can help Veterans stay independent at home. This guide is for Veterans looking for programs and financial support to stay at home. It will also be helpful for families and other caregivers who are part of the Veterans daily life. This guide give information about four VAC programs.

- 1. Treatment Benefits Program provides for a variety of benefits, those most relevant to independence at home include aids for daily living, certain nursing services and special equipment.
- Attendance Allowance provides a monthly tax-free amount to help cover the cost of hiring a caregiver. To determine eligibility for any programs, one must meet certain guidelines which are available through your advocate and if further clarification is needed. Veterans Affairs can be consulted at 1-866-522-2122,

Veterans on Disability Pensions have a much larger Resource Guide available to them, administered by Veterans Affairs.

More Health Care Benefits for RCMP Veterans are available through Eligibility Health Care Programs – RCMP – Veterans Affairs Canada.

In essence "it *stipulated if pensioners of the RCMP*, Canadian Armed Forces, and other government departments get married after the age of 60 years, their spouse is not eligible for any portion of his/her pension once the pensioner dies."



MINUTES FROM EXECUTIVE MEETING HELD ON FRIDAY FEB. 9TH/2024

AGENDA:

1. Opening remarks from Penticton Director Bob Ogden on behalf of Pres. Rob (AOL). Bob advised the sad news that Past President Orv's wife Barbara had passed away peacefully at home on Feb. 6th, following a valiant battle with cancer.

- **2.** Approval of the Minutes from the last Executive Meeting 24-01-12. Motion to approve: Bill Newhouse, seconded by Bill Hacock, all in favour. Passed.
- **3. Treasurer's report:** Year-end statements were presented and discussion concerning the Profit and Loss Net Income deficit of \$824.24. Balance Sheet Total Assets of \$13,055.83.

4. NEW BUSINESS:

- 1. Following up after the discussion of the Membership Research Initiative 2023-24 Finn, Bruce and Kerry prepared their conclusions on the new program. First, the initiative has no relevance to our division other than our current RCMVA BROCHURE that is posted in the South Okanagan Detachments and having our newsletters delivered by the Division Directors to Detachments and talk to members so they can understand the benefits of the RCMPVA. The best action we have had for years is word of mouth and talking to the members who may be interested after retirement.
- **2.** Motion to approve the application for membership by Pasquale Domodossola for membership was deferred as nothing is known of this member.

5. OLD BUSINESS:

1. As brought forward last meeting a division phone list for distribution to all members of the Division has been approved. This new format was agreed upon in that only Last Name, First Name and Phone Number will be released.
