# SUMMERLAND LUNCHEON MEETING SALUTES 50<sup>TH</sup> ANNIVERSARY OF FIRST FEMALE TROOP GRADUATION:

On Saturday, April 20<sup>th</sup> Summerland Director and Past President Orv Robson welcomed our special guest, Supt. Beth McAndie, Officer in Charge, Penticton Detachment and South Okanagan Similkameen District along with 44 Division members to the Summerland Legion for a delicious lunch and special presentation by Supt. McAndie.

Dir. Orv called the meeting to order at 11:50 following an hour of busy social visiting and catch up among the attendees. He thanked all for attending, acknowledged the special guest and members. O Canada was followed by a moment of silence for departed members, and he then called on our Division Chaplain Rev. Rick Gay to offer prayers and say grace.

After a delicious lunch of chef carved ham, baked salmon in lobster/shrimp sauce with full array of vegetables and a large piece of strawberry cheese cake!! Director Orv called on our South Okanagan President, Rob Boulet to introduce our guest speaker – Supt. Beth McAndie.

Supt. McAndie provided a very personal and interesting summary of her career noting she is in her 27<sup>th</sup> year of service having joined at age 21. She mentioned she has great affinity and respect for the Veterans' Association in particular the Vancouver Division with which she is quite familiar and believes in the continuing legacy of the Force that is secure with the Veterans' Association across Canada. She mentioned a number of interesting details of her service which included being the first female member at Hope Detachment for five years prior to being joined by other female members.



She noted that the fellow Hope Detachment members became as brothers to her and secured her choice of selecting a police career. She spent 6 years in the Serious Crime Unit, worked cold cases and travelled on various assignments across Canada. Supt. McAndie noted she is married to a retired member, Fred, and has the joy of being a mother to two wonderful children.

On a more policy part of her presentation Supt.McAndie paid tribute to the first Female Troop 17 that courageously paved the way for others such as herself to seek a career in the RCMP. As she said, Troop 17 underscored the fact that the only limit holding one back is oneself. She has now been Officer In Charge for 4 months and has a passion to ensure any changes will be for the better and to establish an environment that provided an opportunity for success for all members under her command. Holding the members accountable is important but she also has strong views on the benefits of emphasizing wellness and healthy relationships amongst members and their families. The physical area of her command which includes the South Okanagan from Summerland to Osoyoos and Keremeos Detachments is large but she is very pleased with the dedicated and professional members within that region. One major challenge is to maintain the

designated number of police on each watch, typically 7 per shift in Penticton but if calls require members to attend outside Penticton it leaves a significant shortfall in ability to respond to all

calls. But, she pointed to the improved support from the Mayor and others in increasing the numbers of new members being approved under municipal budgets. In closing Supt. McAndie paid special tribute to former Officer In Charge Brian Hunter who as she said had a "big heart" and was a very special and successful head of the region before her.

Division President Rob thanked Supt. McAndie and presented her with a special hand-made wooden bowl by Division Member Glenn Hooper and a business card holder made by Director Orv (**Pictured at right Supt. McAndie and Director and Past President Orv Robson**)

## **IMPORTANT FACTS ABOUT THE FIRST FEMALE TROOP 17:**

- ❖ Troop 17 was sworn in and commenced training on Sept. 16<sup>th</sup>, 1974 and graduated on March 3<sup>rd</sup>, 1975.
- ❖ Troop 17 paved the way for equal opportunity in law enforcement
- ❖ By 2023 the Force consisted of 22% female members
- ❖ Troop 17 included many teachers with troop age from 19 to 29
- ❖ Training was 6 months in Depot Division and copies the training for male recruits with exception of a reduction in the required weight lift of 125 pounds.
- ❖ Major Doris O'Toole was seconded from the Canadian Military to act as training liaison and general assistance due to her previous experience in training female army recruits.
- ❖ Instead of a 32 person barrack the female recruits shared 2 bed rooms.
- ❖ The Over the Shoulder Purse contained their firearm, ammo and handcuffs
- ❖ 1960 saw the adaptation of the same uniform for all members.
- ❖ In 1981 female members joined the Musical Ride.
- ❖ By the 1990s female members were posted as detachment commanders.
- ❖ In 2006 Bev Busson (nee MacDonald) was promoted to RCMP Commissioner.
- ❖ On Sept. 16<sup>th</sup>, 2009 Troop 17 held a reunion at Depot to celebrate 35 years Anniversary.

#### **RESULTS OF SWOT ANALYSIS**

#### **Strengths:**

- Our Association is supported by an efficient and well organized National Office that provides support, certificates to recognized members, liaison with government on policies affecting our membership such as "marriage over 60".
- National Office has updated their website which permits better information to all members and offers a direct link to review their biographical data and dues status etc.
- Our Division continues to have the benefit of an experienced and dedicated executive.
- Our Division establishes annual objectives and monthly executive meetings ensures important items are dealt with promptly.

#### Weaknesses:

- Dwindling membership results in difficulty in finding replacements for an aging executive. Succession Planning remains a major challenge.
- Limited membership results in poor attendance at some Division functions.
- There are no current "committees" in such areas as: Sick and Visiting; Entertainment; Ladies Activities; Special Events; Honour Guard.
- A degree of negativity exists within retired members of the Force who have no wish to continue any association with a formal association such as ours and prefer to attend coffee klatches or join such institutions such as the Legion.
- We currently have a large presence in the Kootenays but could lose up to 10 members if that region joins Kelowna or other division.

#### **Opportunities:**

• Our experienced membership and executive have the ability to be creative and seek new solutions to minimize and mitigate our noted weaknesses.

- Our Division could energize a renewed membership drive and seek current members to join committees and executive positions including such positions as "Assistant Director"; "Assistant Benefit Advocate" etc.
- The degree of liaison with current members and detachment commanders and new O i/c provides an important opportunity to recruit new members.
- Given the existence of the new union in the Force requires we form a link with this association and provide for example, benefit and retirement assistance which is an area that appears wanting if one reads the questions on MP Mates Facebook. Murray Macham is busy responding and clarifying many questions asked by current or recently retired members. Our Advocate Bruce can assist in this area. The delivery of our newsletters and brochures to all detachments within our area is an important initiative.

#### **Threats:**

• Most critical is the lack of a clear succession plan in our Division which will require constant discussion and attention in the coming months.

#### **CONCLUSION:**

Specific deliverables and times to complete were not formalized, however, a number of initiatives are currently being undertaken by all members of the executive and will be reviewed and updated at the next Division Executive Meeting in May.

## **BENEFIT ADVOCATE'S CORNER**

Miscalculation of Disability Pensions Class Action Settlement: Are you a current or former member of the CAF or RCMP or their spouse, common-law partner, survivor dependent, or executor of their estate, who received disability benefits from Veterans Affairs Canada (VAC) between 2003 and 2023? If so, you may be a Class Member and quantifiable for compensation from a class action settlement related to alleged miscalculations of disability pensions and benefits.

Class members with an existing payment relationship with VAC will automatically receive the compensation for which they are quantifiable through the usual payment process. These Class members do not have to submit a Claim Form to receive payment.

Class members who do not have an existing payment relationship with VAC must submit a Claim Form or they will not receive compensation.

NOTE: THE DEADLINE TO SUBMIT A CLAIM FORM IS MARCH 2025.
