In that connection Elizabeth attended the Benefit Support and Advocacy Workshop held in Edmonton in June of this year. Her report follows:



# RCMP Veterans' Assoc. Support & Advocacy Workshop June 5-6, 2024 Submitted by Elizabeth Smith

The Spring workshop was held at Canadian Forces Base Edmonton with the CAF paying for attendees' accommodation and meals. I'm brand new to the program and was pleased to represent the South Okanagan Veterans' Assoc. for the training.

Hosting were Glen Siegersma (CAO of the RCMP Veterans' Assoc.) and Mike Duffy (Support Teams Co-Chair). Also attending were: Dianne Lehman (Edmonton Workshop Coordinator) and Sandra Conlin (RCMPVA President). In addition there were 22 other advocates from across Canada. Presenters were: Melanie Mitra (Calgary), Cheryl Cameron (Virtual Hospice Edmonton), Chris McNeil (Veterans Review & Appeal Board, Charlottetown).

Volunteers with the Support & Advocacy Program are here to help serving and retired members, Public Service Employees, Municipal employees and all of their families, not just Veterans' Assoc. members.

#### Of note:

- New training will be coming this fall to assist homeless Veterans
- Canadian Virtual Hospice is being launched this fall, available to the public to assist with transition, loss and grief
- Chair of the Veterans' Appeal & Review Board spoke about how people don't understand their benefits the highest number of Veterans' Affairs Canada (VAC)

- applications are for "Hearing Loss and Tinnitus" which has surpassed Backs, Hips and Knees
- Canadian Armed Forces created a Transition Support Framework to assist and support employees and their families through every stage of their career, from recruitment to retirement, including promotions and physical transfers
- RCMP is developing a similar program to be rolled out across the country
- Goal of a Transition Framework is to have people leaving the organization as "advocates," not "critics."

## A Friendly Reminder about Computer and Phone Security:

Treasurer Beth McGifford has kindly provided a summary of the latest scams and the continuing effort to part you with your hard earned pension and money:

We all need to be diligent in exercising caution when responding to phone calls, using emails, social media, banking and other apps on our smartphones, tablets and computers. While our March Bulletin had good information courtesy of Jo Ann Ruppenthal here are some updated cautions:

- If you didn't initiate the call you don't know to whom you are talking so be suspicious and DON'T give out any personal information
- Don't click on links or download attachments received in unsolicited messages, even friends can send jokes and pictures that are compromised
- Don't trust a message because it looks legitimate, fraudsters can "spoof" the address
- Use strong passwords for everything and don't use the same password for multiple accounts and devices. Change passwords often.
- Turn off and restart your devices regularly.
- Ensure that software updates on your devices are installed timely.
- Don't stay logged on to applications and databases on any of your devices. Log into these each time, do your business and be sure to LOG OFF.

Closing the browser is also recommended.

Note: if you do fall victim to a fraud or scam share it with your friends and your Division Executive in order to alert our membership.
