THE EMERGENCY RESPONSE TEAM (ERT) – AN ELITE POLICE TACTICAL UNIT COMPRISED OF 16 RCMP MEN AND WOMEN

Formed in 1977, in 31 centres across Canada, the ERT is a group of highly-trained RCMP members capable of employing specialized weapons, equipment and tactics to resolve extremely high-risk situations. ERTs operate as a floating work-site team which allows them to be called from their residences and not necessarily when on duty. Of interest, the ERT teams are legally bound to operate in Canada and overseas when required.

Prospective male and female ERT candidates are required to have two years of operational experience as well as to score a total of 225 or more in their PPC qualifications. Once selected they must complete a nine week ERT Course in Ottawa consisting of theoretical, firearms and tactical training. In addition, Sniper/Observer Course; the Aircraft Assault Course; and the Marine Operations Course are open to ERT members. In 2001 the duties of the ERT were described as follows:

- Resolving incidents involving armed and barricaded persons.
- Aircraft interventions and Marine armed ship boarding
- *High-risk searches and arrests*
- High-risk prisoner transport
- VIP and witness protection duties
- Covert surveillance and intelligence gathering
- Rural tracking operations.



In the event our readers would like to try the physical admission test it is listed below, although it has since been replaced by a timed Obstacle Training Course.

- Run 1.5 mile in under 11 minutes.
- ➤ Complete 40 consecutive and uninterrupted push-ups.
- > 5 wide-grip pull-ups.
- Bench-press a weight of 135 pounds.

Without a doubt it takes a special police officer to meet the criteria and training to complete the ERT requirements. We thank these brave members who assist our detachment members to peacefully or with minimum casualties resolve the many potentially dangerous situations they are required to deal with in our increasingly dangerous society. TAKE CARE!!

RON LYVER OF SOUTH OKANAGAN DIV., RECEIVES MEDAL OF BRAVERY

On October 24th at Rideau Hall in Ottawa, our Division member Ron Lyver was among 40 recipients of Decorations for Bravery. In Ron's case he received the Medal of Bravery, one of Canada's most prestigious honours. *Congratulations Ron, a very proud moment*!



On December 3, 2011, in Breton, Alberta Corporals Peter King and Guy Johnson and Constable Ron Lyver, saved a colleague who was shot on duty. Responding to an active shooter situation, Cpl. Johnson provided cover as Cpl. King and Cst. Lyver ran to assist the victim, with Cpl. King (Now Supt.) getting shot twice. Cst. Lyver returned fire allowing them to move their colleague to safety. Also receiving the Medal of Bravery were Cpl. Johnson of Red Deer, and Supt. Peter King of Grand Prairie.

We will host a series of workshops at each of our region's detachments coordinating dates through the Regional Directors, Detachment Commanders - Starting in Penticton, all serving and retired (Assoc. members and civilian, auxiliary & municipal employees are welcome. This includes items such as: hearing aids; vision care; dental and medical costs; prescriptions; special equipment; physiotherapy; occupational therapy; psychological services; nursing services

- Challenged the \$30 billion pension surplus grab in the superannuation accounts
- Established preferred partners and saving for travel and home insurance and many savings for its membership.
