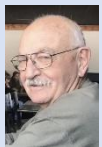

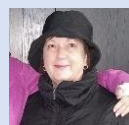

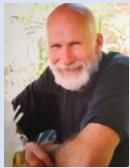

Subject: Association President's Statement on Budget 2025 Veterans

Many of you have contacted the Association in the past two weeks regarding Budget 2025 and the legislative amendments impacting upon RCMP Veterans as it concerns disability pensions; specifically, as it relates to

(i) proposed modification of the escalation formula of the Disability Pension, so that the

benefit is indexed based on the Consumer Price Index alone, for serving and retired RCMP members and for related benefits, effective January 2027 (including on a retroactive basis);

(ii) proposed amendments to the Royal Canadian Mounted Police Superannuation Act, as well as any other consequential, coordinating or transitional amendments as necessary, to clarify, retroactively and on a prospective basis, the authority to administer and adjudicate disability award applications and to deliver health treatment for RCMP members, former members, and survivors and to delegate certain functions to an eligible federal organization.

As Veterans, we are all concerned about the potential implications of these legislative amendments.

We are in active dialogue with Veterans Affairs Canada, RCMP and National Police Federation seeking specifics on what impact these proposals will have monetarily and potentially in terms of service delivery.

Unfortunately, as we all know, when facts are unavailable, rumour fills the void. We want to be able to provide our Veterans with facts so that you can best assess the impact upon yourselves and not be misled by inaccurate information.

Once we have reliable, verified information on these issues, we will share it responsibly with the RCMP Veteran community.

Once credibly informed, we'll be better positioned to assess next steps.

HISTORICAL CORNER

40 YEARS (ISH) AGO IN THE RCMP

#23499 Constable 3rd class Reginald Wayne Williams drowned, while on patrol, when his police car skidded off of a wharf and plunged into the water. While on routine patrol on the

icy streets of Sooke British Columbia Cst. Williams drove onto Government dock and skidded off the end, dropping 18 feet into the frigid water. Although his vehicle was pulled out from 12 feet of water within 15 minutes he had died from drowning. 21-year-old Cst. Williams had joined the RCMP only eight months earlier. He was buried in his hometown of Portage la Prairie, Manitoba at the Hillside Cemetery.

1968 – Four teenagers were cruising the icy roads of rural Prince Edward Island when their car left the highway and overturned in five feet of water in Fullerton's Marsh. Constables #22436 D.R. MacLeod and #24551 D.D. MacDonald responded to the scene and rushed into the water, managing to remove three of the occupants to safety. The driver, Clifford Smith, couldn't be removed because his legs were trapped and he was suffering from shock. So the two policemen took turns entering the car and holding the victim's head up in an air space. After an hour in the icy water the vehicle was raised using a crane and the driver was removed. Constable MacLeod had to be treated in hospital for hypothermia. Both constables were awarded Life Saving Certificates by the Honourable J. George MacKay, the Lieutenant Governor of Prince Edward Island.

ADVOCACY and SUPPORT

To the many veterans who participate in the Support & Advocacy Program of the RCMP Veterans' Association here is why we do what we do.

In June 1978 this young guy, scared as hell, marched into the drill hall with the others in his troop. Like all troops they performed what was required and six months later instructors like myself looked skyward asking the Good Lord to look after them, for they really were going to a job they knew nothing

about but would take everything they had out of them.

I was fortunate in those years, as often I would make notes to myself on paperwork which was submitted on recruits. It wasn't very hard to see these young people and in six months be able to make a mental note that some would exceed all expectations and move onto the commissioned ranks. I could name a few notables here, but I'll spare their embarrassment.



This is retired Insp. Brian Andrews who went to British Columbia and over the years had a successful

career. However, in the early 2000's he was being trained on use of force and the instructor used Brian as the test dummy to demonstrate the carotid control. It did not go well and the long story short was the demonstration caused the arteries to become dissected and that evening he ended up in emergency. Since 2001 he has suffered several setbacks. The Force very correctly issued a directive about the procedure. Brian's medical journey continued over the years, at one point he went down at home and his son found him nonresponsive. A call to 911 said an ambulance was more than 30 minutes away. His son, a volunteer fireman in the community, picked his dad up, literally threw him in the car and drove him to the hospital, where the ER witnessed a big young man carrying his father through the door looking for help. The son is now a member of the Force.

Brian and I reunited through a coffee clutch meet up several years ago and he told me his story. It was those meetings that we discussed Veterans Affairs and benefits. Some benefits he was missing out on were the

Attendance Allowance and Exceptional Incapacity Allowance, and it was explained how he could further his claims through medical professionals he was in contact with. He also needed the first decision to be reassessed. Coincidentally his neurosurgeon was very aware of his condition and had a medical journal article that was describing Brian's case to exactness.

At our veteran's levee on January 10, it was a great pleasure to sit with Brian and learn the success he has had with Veterans Affairs. Proof there is light at the end of the tunnel, but it takes time.

It's why we do what we do in Support & Advocacy.

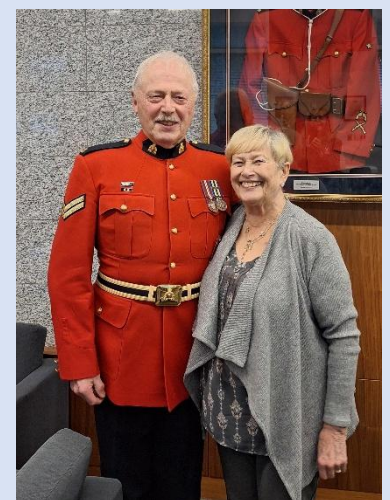
